DECISION

On amendment and supplement for provisions at the Clauses 1 and 2, Article 10 of the Regulation on responsibilities of staff and learners in the exam sessions of VNUHCM-University of Science

RECTOR OF VNUHCM-UNIVERSITY OF SCIENCE

Pursuant to Decision No. 26/2014/QĐ-TTg dated March 26th, 2014 of the Prime Minister on promulgating organization and operation regulation of the Viet Nam National University Ho Chi Minh City (VNUHCM) and higher education institutions under VNUHCM;

Pursuant to Decision No. 867/QĐ-ĐHQG-TCCB dated August 17th, 2017 of Vietnam National University Ho Chi Minh City on promulgating organization and operation regulation of higher education institutions and faculties under VNUHCM;

Pursuant to Circular 10/2016/TT-BGDĐT, dated April 5th, 2016 of the Minister of Education and Training promulgating the Regulation on student work for formal undergraduate study programmes;

Pursuant to Decision No. 43/2007/QĐ-BGDĐT dated August 15th, 2007 of the Minister of Education and Training promulgating the Regulation on formal university and college-level training under the credit system, revised and supplemented by Circular 57/2012/TT-BGDĐT dated December 27th, 2012 of the Minister of Education and Training, being effective from February 10th, 2013;

Pursuant to Decision No. 373/QĐ-KHTN dated March 19th, 2018 of VNUHCM-University of Science's rector on promulgating Regulations on responsibilities of staff and learners in exam sessions;

At the request of the Head of Education Testing and Quality Assurance Office.

DECISION:

Article 1. The Provisions amendments and supplements to Clauses 1 and 2, Article 10 of the Regulations on responsibilities of staff and learners in exam sessions promulgated together with Decision No. 373/QĐ-KHTN dated March 19th, 2018 by the Rector of VNUHCM-University of Science as follows:

Article 10. Handling learners who violate exam regulations:

1. Reprimand: Apply to learners who make mistakes one time: look at other learners' exam papers and discuss with other learners during the exam session.

Learners who are disciplined with reprimand while taking the exam will be deducted 25% from that module's total grade

2. Warning: For learners who violate one of the following mistakes:

a. Being reprimanded once but during that exam, the learner continues to violate the exam regulation;

b. Exchange your work or draft paper;

c. Bringing exam materials, cell phones, or other unallowed devices into the exam room (even unused);

d. Copying other learners' exam papers, intentionally letting other learners copy learners' exam papers. If the learner being handled has enough evidence to prove that it is not her/his fault, he/she will be considered for prosecution exemption.

Learners who are disciplined with a warning level while taking any exam will be deducted 50% of that module's total grade

Article 2. This Decision takes effect from the date of signing.

Article 3. Heads of Offices, Deans of Faculties, learners, and relevant individuals are responsible for the implementation of this Decision.
